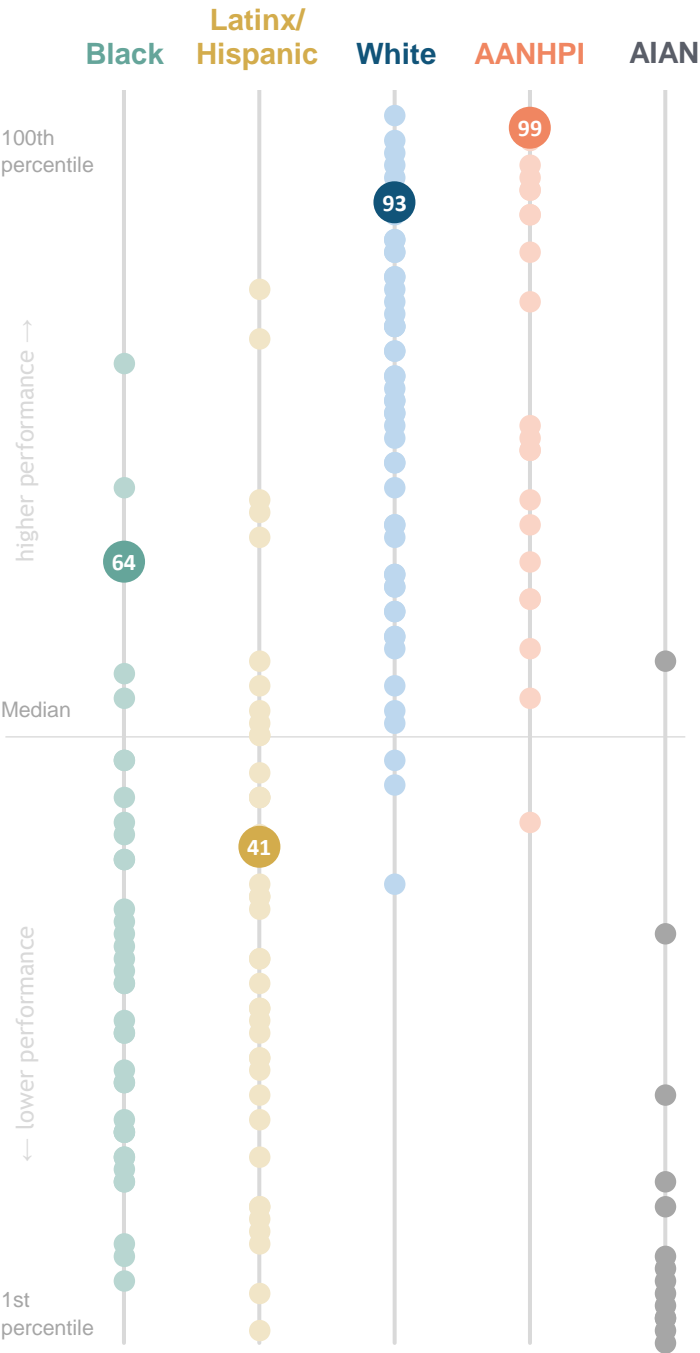


Health Equity in Maryland
