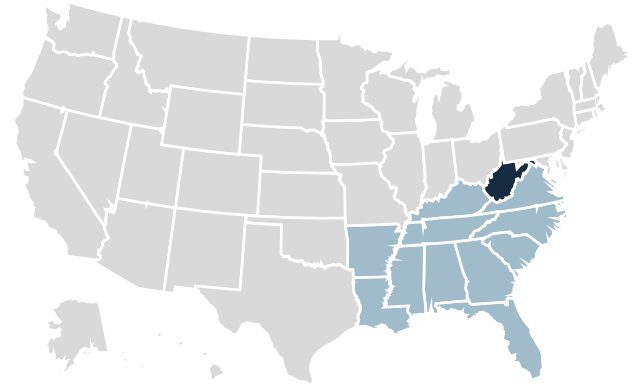

### West Virginia ranks #47 overall.

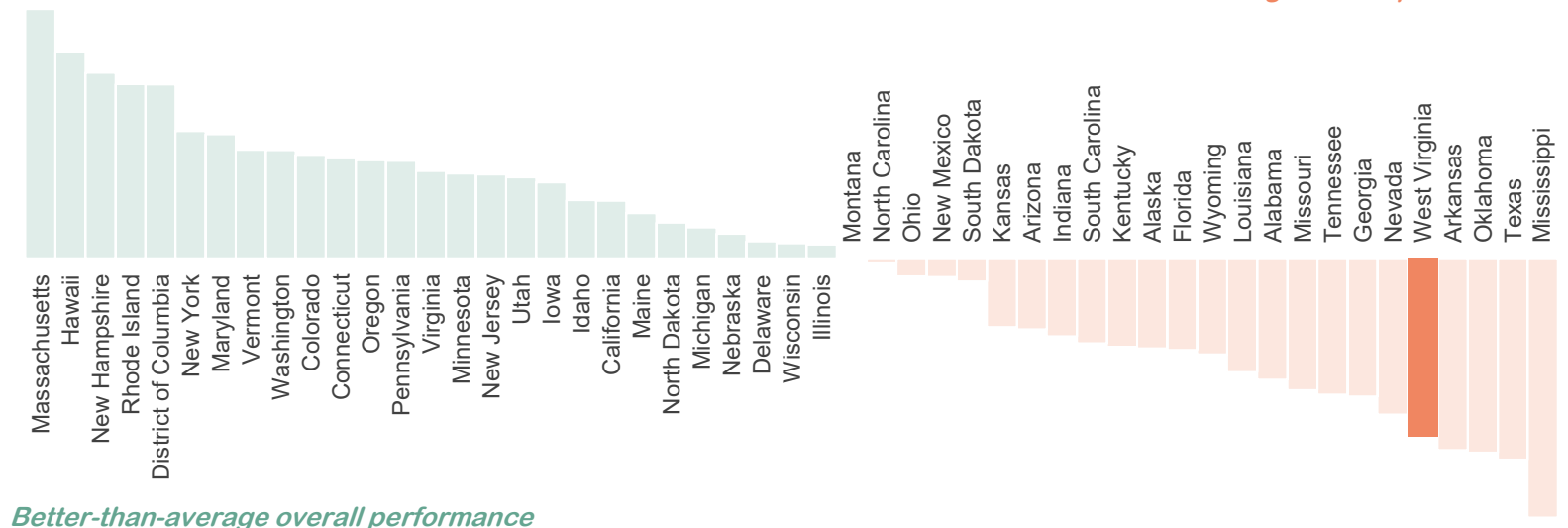

<sup>a</sup> The 2025 State Scorecard rankings generally reflect 2023 data. The 2025 Scorecard added or revised several performance measures compared to earlier editions; rankings are not comparable between reports.

<sup>b</sup> Trend data available for 45 of 50 total Scorecard indicators. For indicators where trends were possible, the baseline period generally reflects five years prior to the time of observation for the latest year of data available (often 2019). Improved/worsened denotes a change of at least one-half (0.5) standard deviation larger than the indicator's distribution among all states over the two time points. No change denotes no change in rate or a change of less than one-half standard deviation.

<sup>c</sup> Several of the indicators in the Healthy Lives dimension are also nested in the definition of Preventable and Treatable deaths. We made an adjustment in our ranking method to account for this to avoid double-counting mortality from certain causes (e.g. deaths from breast cancer). Note that this adjustment is only reflected in the ranked values for preventable and treatable mortality; the values reported in charts and the report appendix are unadjusted.

<sup>d</sup> Rates are for each state's low-income population, generally those whose household income is less than 200% of the federal poverty level (FPL).
