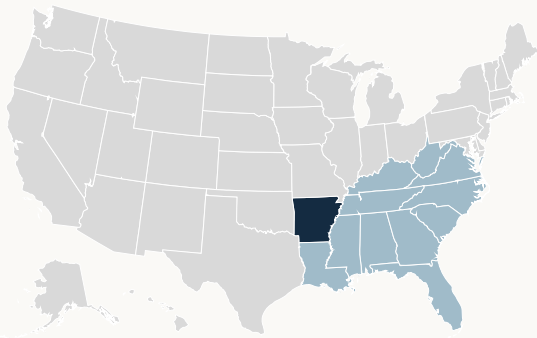

Arkansas ranks #47 overall.

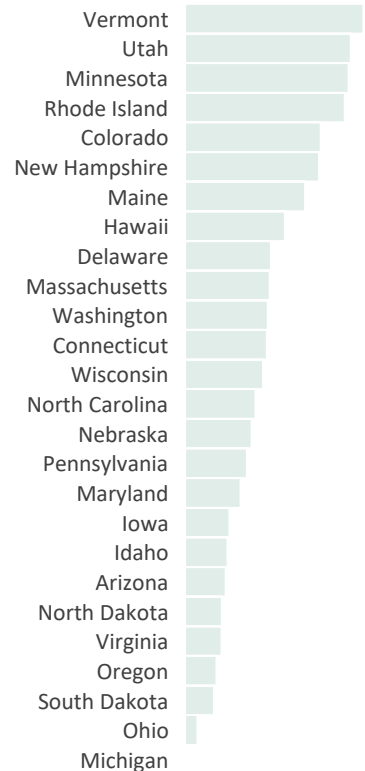

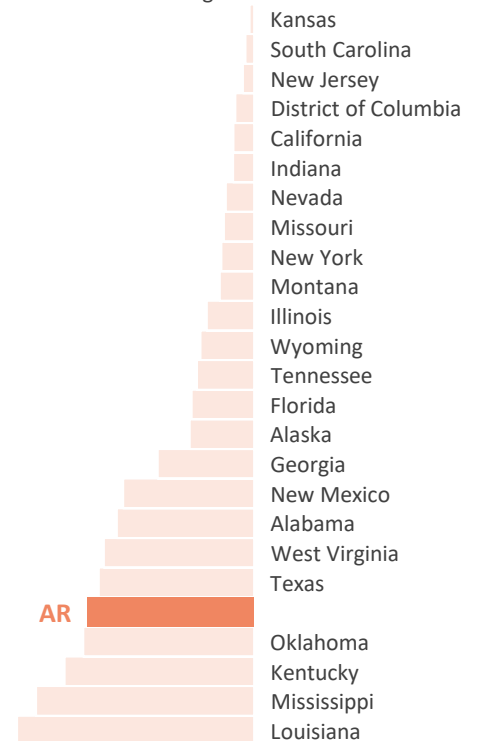
