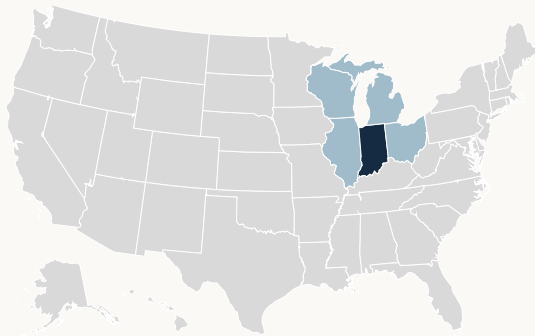

Indiana ranks #32 overall.

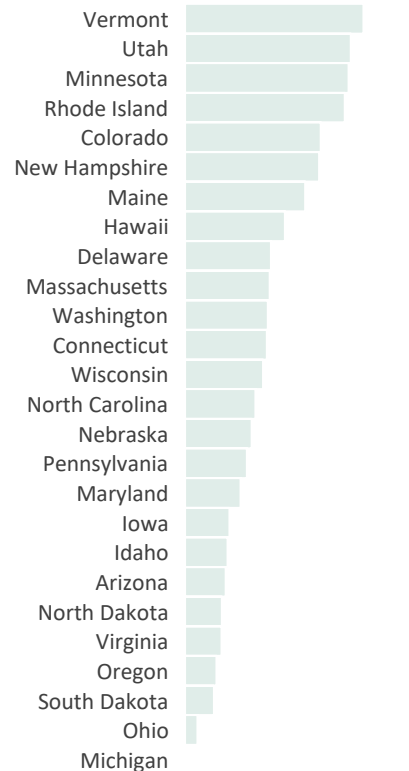
