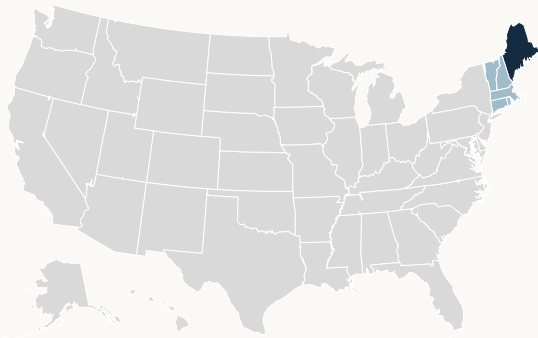

Maine ranks #7 overall.

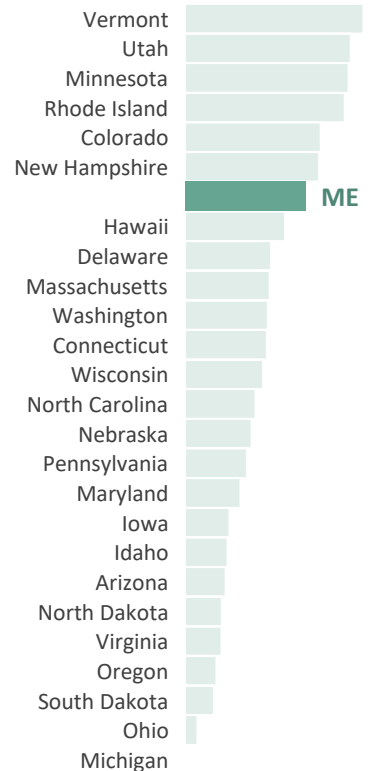

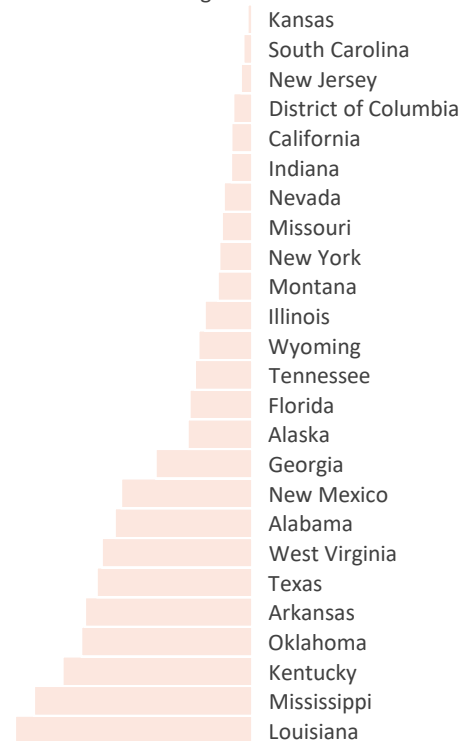
