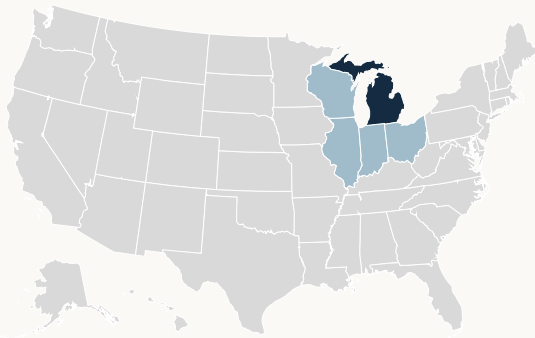

Michigan ranks #26 overall.

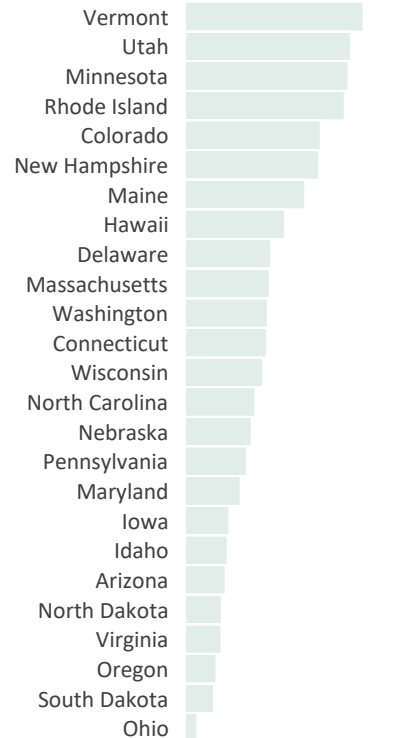
