

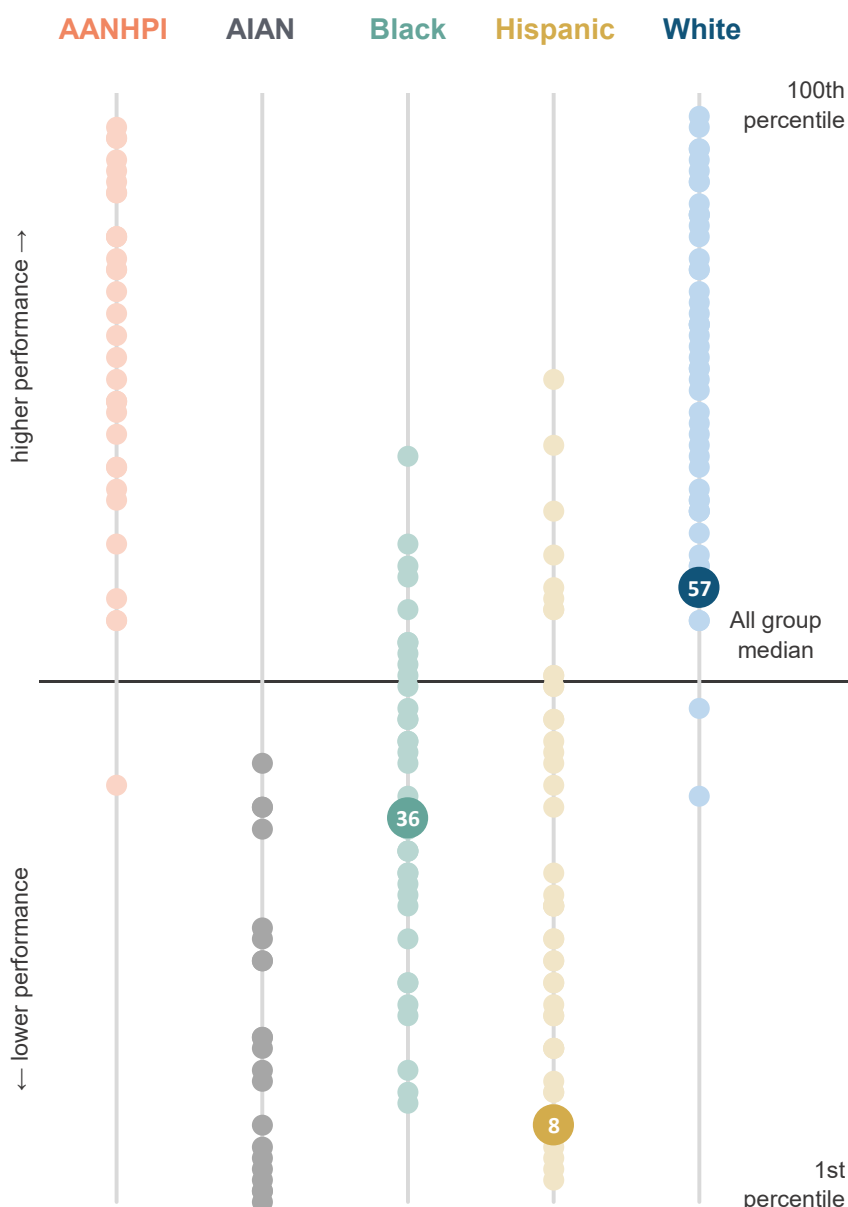
# How well does the health care system in **Kentucky** work for people of different racial and ethnic groups?

In Kentucky, **White people** experienced the **best health care outcomes, access, and quality**, scoring in the 57th percentile among all population groups nationally.

**Hispanic people** experienced the **worst health care outcomes, access, and quality** in the state, scoring in the 8th percentile.

Compared to other states in the Southeast region, Kentucky has **less severe** racial and ethnic health disparities.

Each column is a racial/ethnic group, and each point represents a state. Performance represented as percentiles (1–100). Kentucky performance percentile highlighted. No highlighted dot indicates overall performance data not available for that group.

# How well does the health system in Kentucky work for people from different racial and ethnic groups and across different dimensions of care?

## AANHPI

## Black

Kentucky ranks 20th among the 39 states we were able to rank. This indicates that the state's health system performance for Black people was worse than the average compared to other states.

Health outcomes ranking: **31** (of 41) is worse than the average  
Health care access ranking: **24** (of 41) is worse than the average  
Health care quality ranking: **15** (of 45) is better than the average

## Hispanic

Kentucky ranks 43rd among the 49 states we were able to rank. This indicates that health system performance for Hispanic people was worse than the average compared to other states.

Health outcomes ranking: **35** (of 50) is worse than the average  
Health care access ranking: **32** (of 50) is worse than the average  
Health care quality ranking: **45** (of 50) is among the worst

## White

Kentucky ranks 47th among the 51 states we were able to rank. This indicates that the health system performance for white people was among the worst compared to other states.

Health outcomes ranking: **50** (of 51) is among the worst  
Health care access ranking: **33** (of 51) is worse than the average  
Health care quality ranking: **44** (of 51) is worse than the average
